DECISION on contract awarding

In the process of the joint procurement of equipment and software no. TEMPUS 01/2015 for the needs of the following partners implementing the Tempus Project 544543-TEMPUS-1-2013-1-RS-TEMPUS-JPCR: Business and Technical College of Applied Sciences in Užice, University of Kragujevac, Faculty of Hotel Management and Tourism in Vrnjačka Banja and Business College of Applied Sciences in Leskovac, the bid submitted on the Lot 18 by the bidder **Best Solutions LLC** from Belgrade, whose address is Molerova 15/6, was determined as the most advantageous one. The bid is registered under the number 696, dated 27th March 2015, with the bidder and under the number 735, dated 31st March 2015, with the contracting authority. In compliance with the approved contract model, the Contract on Public Procurement of the Specified Software will be awarded to this bidder.

Rationale

Based on the Decision on Initiating the Procedure of the Joint Procurement of Equipment and Software no. 166, dated 30th January 2015, the procedure of awarding the contract on public procurement for the Lot 18 was carried out in the process of the joint procurement TEMPUS 01/2015, pursuant to Article 39 of the Law on Public Procurement ("Official Gazette of the Republic of Serbia", no. 124/12).

1. The invitation to bid

TEMPUS 01/2015 was published on the Public Procurement Portal and posted on the website of the contracting authority (www.vpts.edu.rs) and the partners on 2nd March 2015. At the same time, an email with the invitation was sent direct to the following potential bidders:

The deadline for the submission of bids, which was specified in the invitation to bid, was 31st March 2015, until 11 am.

2. The received bids on the Lot 18:

The Committee responsible for carrying out the joint procurement procedure stated that only one bid had arrived on the Lot 18 at the address of the contracting authority within the specified deadline, and this was:
