Pursuant to Article 7, paragraph 1, item 2, sub-item a) of the Law on Public Procurement ("Official Gazette RS" No. 124/2012), the opinion of the Public Procurement Office no. 011-00-88/10 dated 8th November 2010, the Instructions for Equipment Procurement in the TEMPUS and Erasmus Mundus Projects (determined by the Tempus Foundation), as well as according to the Contract on the Implementation of the Tempus Project no. 544543 and the Report on the Expert Evaluation of Bids for Lots, no. 981 dated 21st April 2015, submitted by the Committee, the following contract award decision has been made

DECISION
on contract awarding

I In the procedure of the joint procurement of equipment and software no. TEMPUS 01/2015 for the needs of the following partners implementing the Tempus Project 544543-TEMPUS-1-2013-1-RS-TEMPUS-JPCR: Business and Technical College of Applied Sciences in Užice, University of Kragujevac, Faculty of Hotel Management and Tourism in Vrnjačka Banja and Business College of Applied Sciences in Leskovac, the following bids on the lots 1-17 were determined as the most advantageous and, in compliance with the approved contract model, the Contract on Public Procurement of Equipment and Software will be awarded to the following bidders:

23	The bid no.736, submitted by the bidder “JAPI COM“ LLC Novi Sad, the bid no. 883, submitted by the bidder “GOLUM“ LLC Belgrade, and the bid no. 884, submitted by the bidder “Tehnicom informatika“ Niš, the branch in Belgrade, did not comply with the required technical characteristics and they significantly exceeded the estimated values for the Lot 23

As to the lots 19-23, the approval to repeat the procedure should be sought.

The report on the expert evaluation of the bid no. 981, dated 21st April 2015, is an integral part of this Decision.

Rationale

Based on the Decision on the Initiation of the Procedure of the Joint Procurement of Equipment and Software no. 166 dated 30th January 2015, the procedure of awarding the contract on public procurement by lots was conducted in the process of the joint procurement TEMPUS 01/2015, pursuant to the Law on Public Procurement (“Official Gazette of the Republic of Serbia”, no. 124/12) and the Report of the Committee on the Expert Evaluation of the Bids no. 981, dated 21st April 2015, the Decision as stated in the main text has been made.
