As part of Tempus project Modernization and harmonization of Tourism study programs in Serbia 544543-TEMPUS-1-2013-1-1-RS-TEMPUS-JPCR, Higher Business School of Professional Studies has established cooperation and signed Cooperation agreements with 37 tourism and hospitality enterprises.

Business cooperation which is the subject of Cooperation agreement has the aim of:

- Development and realization of specialized trainings and courses for students and tourism workers.

Stakeholders (business enterprises with which HBSL signed Cooperation agreements) have, during the Projects implementation, actively participated in:

- Offering suggestions with modernization of reaccredited study program

- Tourism workshops that HBSL has organized;
- Realization of 4 workshops that stakeholders held at HBSL (workshops for students of HBSL);
- Regular meetings which HBSL organized with stakeholders with the aim of developing new projects of joined interest (these projects being a part of Project sustainability).

One of the results of cooperation is a tourism development strategy of city of Leskovac.

HBSL's cooperation with stakeholders will continue even after the Project ends, especially in the area of organization and realization of professional practice programs, education, trainings and professional development of tourism workers. All professional development programs and trainings that HBSL might organize will be in accordance with the needs of stakeholders. We expect that stakeholders will keep on devising lectures for HBSL's students. Moreover, we hope that we will keep on cooperating in the area of developing and executing research and developmental projects of common interest. In the course of Project implementation, we organized a meeting (attended by relevant stakeholder and HBSL representatives) once a month, and we plan on doing the same after the Project ends.
