Within the first item of the agenda, Director in charge of BTC Uzice greeted the meeting attendees and wished them a successful work.

Within the second item of the agenda, Project coordinator firstly commented on all the questions from Annex 2 and supporting documents provided by TEMPUS Office before monitoring visit. He delivered answers to the TEMPUS Office representatives in written and electronic form. Then the representatives of the TEMPUS Office raised questions to coordinator of the project in order to clarify details regarding the Report on the current implementation of the "MHTSPS" project.

After that, TEMPUS Office representatives raised questions to the present representatives of all Serbian partners in the Project and gained answers and clarifications.

At the end, it is stated that the Work Plan for previous four months of the project implementation has been realized completely. Additionally, activities **DEV 9.5 – Design of manual for financial project management** and **DEV 6.1 – Defining procedures for project quality control** have also been implemented. It was also stated that the procurement of ICT equipment will start earlier in order to have it installed as soon as possible, so the training courses for teachers and associates at partner higher education institutions from Serbia can be implemented.

Within the third item of agenda, it has been agreed that partner higher education institutions from Serbia will define suggestions related to equipment and software to be purchased no later than 5 April 2014. These suggestions should be in accordance with the previously obtained results, especially with the deliverables of Activity 1.1 and Activity 1.2. TEMPUS Office representatives provided answers to numerous questions regarding project finances and modes of funds transfer within the Project.

Most of the questions were related to eligibility of financing a certain expenses, as well as to modalities of normative regulation of paying the wages for realized activities to the non-academic partners. In order to assure further successful implementation of the Project, it has been agreed that the TEMPUS Office and The Education, Audiovisual and Culture Executive Agency should be consulted on each issue in dispute.

The session ended work at 14:00 CET.
