Pursuant to Article 42, paragraph 1 of the Law on Higher Education (“Official Gazette RS”, no. 76/05, 100/07 – the authentic interpretation, 97/08, 44/10, 93/12, 89/13 and 99/14) and Article 206, paragraph 1 of the Law on General Administrative Procedure (“Official Gazette FRY”, no. 33/97 and 31/01) and (“Official Gazette RS”, no. 30/10), the Minister of Education, Science and Technological Development is issuing the following

DECISION
ON THE AMENDMENTS OF THE WORK PERMIT

The Business and Technical College of Applied Sciences in Užice, 34 St Sava’s Square, is allowed to carry out its activities and implement the following accredited study programme:

Specialist Vocational Studies – **TOURISM with two modules: MANAGEMENT OF TOURISM DESTINATIONS and ECOTOURISM**

The Accreditation and Quality Evaluation Commission has issued to the Business and Technical College of Applied Sciences in Užice, the following:

Certificate number 612-00-02204/2014-04 dated 28th November 2014 on the accreditation of the study programme: Specialist Vocational Studies – **TOURISM with two modules: management of Tourism destinations and Ecotourism**, which can enroll 50 (fifty) students in the first year of studies at the institution’s seat.

Rationale

The Business and Technical College of Applied Sciences from Užice submitted to the Ministry the request number 208 dated 5th February 2015 to be issued the amendment of the work permit for the accredited study programme: Specialist Vocational Studies – **TOURISM with two modules: Management of Tourism Destinations and Ecotourism**.

The Work Permit number 612-00-1014/2007-04 dated 8th October 2007, the Decision on the Amendment of the Work Permit number 612-00-02305/2009-04 dated 6th May 2010 and the Decision on the Amendment of the Work Permit number 612-00-02277/2011-04 dated 29th March 2013 and the Decision on the Amendment of the Work Permit number 612-00-01090/2014-04 dated 17th October 2014 do not include the

accredited study programme - Specialist Vocational Studies – TOURISM with two modules: Management of Tourism Destinations and Ecotourism and therefore, pursuant to Article 206, paragraph 1 of the Law on General Administrative Procedure (“Official Gazette FRY”, no. 33/97 and 31/01) and (“Official Gazette RS”, number 30/10), the Decision on the Amendment of the Work Permit has been issued.

Legal remedy: This decision is final in the administrative procedure and an administrative proceeding may be initiated against it. The appeal should be submitted to the Administrative Court of Serbia no later than 30 days starting from the day of receiving the decision.
