Pursuant to Article 42, paragraphs 1 and 10 of the Law on Higher Education ("Official Gazette RS", no. 76/05, 100/07 – the authentic interpretation, 97/08, 44/10, 93/12, 89/13 and 99/14) and Article 206, paragraph 1 of the Law on General Administrative Procedure ("Official Gazette FRY", no. 33/97 and 31/01) and ("Official Gazette RS", number 30/10), the Minister of Education, Science and Technological Development is issuing the following

DECISION ON AMENDMENTS AND CHANGES OF THE WORK PERMIT

1. The Business and Technical College of Applied Sciences, with the seat in Užice, 34 St Sava's Square, is allowed to carry out its activities and implement the following accredited study programmes:

Undergraduate vocational studies – INFORMATION TECHNOLOGIES with two modules: INFORMATION SYSTEMS and MULTIMEDIA AND DIGITAL TELEVISION

Undergraduate vocational studies – ACCOUNTING AND AUDIT

Specialist vocational studies – MECHANICAL ENGINEERING with the modules MANUFACTURING ENGINEERING and THERMOTECHNICS.

2. The changes of the work permit, issued to the College, relate to the number of students who may enroll in the accredited study programmes:

Undergraduate vocational studies – Mechanical Engineering with the modules Manufacturing Engineering and Thermotechnics can enroll 44 (forty-four) students.

Undergraduate vocational studies – **Environmental Protection Engineering** can enroll 66 (sixty-six) students.

Undergraduate vocational studies – Management can enroll 93 (ninety-three) students and

Undergraduate vocational studies – **Tourism** can enroll 93 (ninety-three) students.

Rationale

The Law on Higher Education, Article 42, stipulates the procedure of changing and amending a work permit upon the request submitted by a higher education institution. The ministry in charge of higher education activities takes the request into consideration and issues the appropriate decision in compliance with the mentioned law and the Law on General Administrative Procedure.

The Business and Technical College of Applied Sciences submitted to the Ministry the following requests: number 2440 dated 23rd July 2013, number 1237 dated 13th May 2014 and number 1705 dated 25th June 2014, to be issued the Amendment of the Work Permit number 612-00-1014/2017-04 dated 8th October 2007.

The College enclosed the appropriate documentation with the request, the certificates on the accreditation of the College and its study programmes, issued by the Accreditation and Quality Evaluation Commission in the regular accreditation process, as well as other accreditation certificates which are necessary for the amendments and changes of the work permit. These include:

Certificate number 612-00-00850/2013-04 dated 7th June 2013 on the accreditation of the study programme Undergraduate vocational studies – **Information Technologies with two modules: Information Systems and Multimedia and Digital Television**, for the enrolment of 88 (eighty-eight) students in the first year of studies at the institution's seat,

Certificate number 612-00-00850/2013-04 dated 28th June 2013 on the accreditation of the study programme Undergraduate vocational studies – Accounting and Audit, for the enrolment of 33 (thirty-three) students in the first year of studies at the institution's seat,

Certificate number 612-00-00340/2014-04 dated 9th April 2014 on the accreditation of the study programme Specialist Vocational Studies – **Mechanical Engineering with the modules: Manufacturing Engineering and Thermotechnics**, for the enrolment of 32 (thirty-two) students in the first year of studies at the institution's seat,

The Amendment of the Certificate number 612-00-00851/2013-04 dated 10th May 2013 on the accreditation of the study programme Undergraduate vocational studies – **Mechanical Engineering with the modules: Manufacturing Engineering and Thermotechnics**, for the enrolment of 44 (forty-four) instead of 60 (sixty) students in the first year of studies at the institution's seat,

The Amendment of the Certificate number 612-00-00851/2013-04 dated 10^{th} May 2013 on the accreditation of the study programme Undergraduate vocational studies – **Environmental Protection Engineering**, for the enrolment of 66 (sixty-six) instead of 60 (sixty) students in the first year of studies at the institution's seat

The amendment of the Certificate number 612-00-00851/2013-04 dated 10th May 2013 on the accreditation of the study programme Undergraduate vocational studies – **Management**, for the enrolment of 93 (ninety-three) instead of 99 (ninety-nine) students in the first year of studies at the institution's seat,

The amendment of the Certificate number 612-00-00851/2013-04 dated 10th May 2013 on the accreditation of the study programme Undergraduate vocational studies –

Tourism, for the enrolment of 93 (ninety-three) instead of 110 (a hundred and ten) students in the first year of studies at the institution's seat.

Since the Work Permit number 612-00-1014/2007-04 dated 8th October 2007, the Decision on the Amendment of the Work Permit number 612-00-02305/2009-04 dated 6th May 2010 and the Decision on the Amendment of the Work Permit number 612-00-02277/2011-04 dated 29th March 2013:

- do not include the new accredited study programmes: Undergraduate vocational studies Information Technologies with two modules: Information Systems and Multimedia and Digital Television, Undergraduate vocational studies Accounting and Audit and Specialist Vocational Studies Mechanical Engineering with the modules Manufacturing Engineering and Thermotechnics,
- do not include the amendments of the approved number of students to enroll in the accredited study programmes: Undergraduate Vocational Studies: Mechanical Engineering with the modules Manufacturing Engineering and Thermotechnics, Environmental Protection Engineering, Management and Tourism,

it has been decided as stated in the wording of the Decision.

Legal remedy: This decision is final in the administrative procedure and an administrative proceeding may be initiated against it. The appeal should be submitted to the Administrative Court of Serbia no later than 30 days starting from the day of receiving the decision.
