Within the first item of the agenda, Marija Mandaric, PhD and Sofija Dukic greeted the meeting attendees and wished them a successful work. Participants were informed about preparation about new study program accreditation - Health Tourism at FHIT UNIKG.

She pointed out that all Departments, administrative and financial, should be involve in project implementation (international office cooperation - project application, IT for equipment purchase...). Marija Gačic, Financial Department, emphasized the procedures for accounting and financial report and workflows of documentation.

III

Within the third item of the agenda, Project coordinator presented the project results and emphasized the problems according to equipment purchase and accreditation of new study programs. After that the representatives of the TEMPUS Office promised understanding and conversation with KAPK and raised questions to coordinator of the project in order to clarify details regarding the Report on the current implementation of the "MHTSPS" project. TEMPUS Office representatives raised questions to the present representatives of all Serbian partners in the Project and gained answers and clarifications.

Within the fourth item of agenda, it has been agreed that partner higher education institutions from Serbia will accredited new study program:

- at HBS Leskovac: postgraduate study program Business Economy and Tourism, and undergraduate study programs Tourism and Hotel Management and Food Technology Management and Gastronomy;
 - at FHIT Vrnjačka Banja: undergraduate study program Health Tourism and
- at BTC Uzice: undergraduate study program Tourism and specialist vocational studies Ecotourism.

Total: 4 undergraduate study programs and 2 specialist (postgraduate) vocational studies.

At the end, it is stated that the Work Plan for previous four months of the project implementation has been realized completely.

The session ended work at 14:00 CET.
